3. To confirm the minutes of the meeting held on the 18th November 2015 and report on any matters arising.

Cllr Lewendon proposed and it was seconded by Cllr Perkins and therefore **RESOLVED**: that the minutes of the meeting held on the 18th November 2015 be signed as a true record.

5. To report on matters relating to the Recreation Ground

<u>Dugouts</u> – Members considered the further information received from the Turks FC regarding their request for provision of permanent Dugouts at the Recreation Ground – this included photographs of similar dugouts, details of design and size together with assurance that there would be no cost to the Council. The Council had also received advice from the Hampshire Football Association regarding criteria for progression of clubs into the Hampshire League.

Cllr Lewendon proposed and it was seconded by Cllr Fulford and therefore **RESOLVED**: that permanent dugouts should not be provided at the Recreation Ground as this would conflict with the open nature of the grounds – any dugouts provided should be of a temporary and moveable design.

Rabbit Problem – The Chairman confirmed that a letter had been sent to the owner of Brownsey's Field advising of the Council's intention to employ a qualified and insured person to deal with the rabbits on the Rugby Pitch. Concern was raised that rabbits were present on neighbouring land which the Council could not control, this is despite rabbit proof fencing being provided.

<u>Whitsbury Road Play Area</u> the Clerk reported that following concerns raised over the matting being damaged after flooding, that this would prioritised for replacement or consideration given to the re-siting of the play park onto higher ground. Members raised concern that the problem arises due to the narrow channel of the adjacent river as weed growth no longer controlled.

7. To report on any Tree Works

The Chairman reported on two quotes received from Gristwood & Toms and Avon Tree Care in the sum of £1237.00 and £1190.00 respectively.

Cllr Anstey proposed and it was seconded by Cllr Lewendon and therefore **RESOLVED**: that the quote from Avon Tree Care in the sum of £1190.00 be accepted for the tree worked identified in the Annual Survey. All in favour.
