Cllr Fulford reported on both applications for works to this Listed Building in order to convert the premises to a beauty salon. Members noted that the walkway which is contained within the curtilage to the left of the property (viewed from Salisbury Street) has a right of access through it for properties at the rear. Concern has been raised regarding the proposed air vents which would be discharging onto the walkway. Cllr Price raised concern over what would be emitted through the vents and if there would be any chemical content from the salon. The applicant, who was present at the meeting, explained that the vents were required to provide ventilation as there are no opening windows and it would not be possible to leave the door open – he confirmed that no chemical or gases would be emitted through the vents.

Cllr Hale proposed and it was seconded by Cllr Anstey and therefore **RESOLVED**: to recommend that permission be granted under PAR3 as the proposal provided a good use of the building with commercial and residential use.
